

Website Terms & Conditions

of use

Access and use of this site is provided by FM Cosmetics Distribution UK Limited subject to the following terms:

1. By using this site you agree to be legally bound by these terms, which shall take effect immediately on your first use of the site. If you do not agree to be legally bound by all the following terms please do not access and/or use the site.
