|---|---|----------|-----------------|---|
| 3%-12%  | 12% or higher                                 | REQUIRED | 150             | Double commission from February 2025 (Paid in April 2025) |
| 15%   | 15% or higher                                 | REQUIRED | 150             | Double commission from February 2025 (Paid in April 2025) |
| 18%   | 18% or higher                                 | REQUIRED | 150             | Double commission from February 2025 (Paid in April 2025) |

## Example

- Your Effectiveness Level in November 2024 was 15%.
- In February 2025, you achieve 15% or more and earn £200 in commission.
- You meet the 60/40 rule.
- In April 2025, you receive an additional £200, doubling your February earnings!

# Additional Participation Conditions

- The programme is available to Business Partners who had an Effectiveness Level **of 3%-21% in November 2024.**
- To receive the additional commission, you must meet the 60/40 rule.
- Required UK Points for each Effectiveness Level:
  - **12% – 7,200 UK Points**
  - **15% – 12,000 UK Points**
  - **18% – 20,400 UK Points**
  - **21% – 30,000 UK Points**
- At least 150 Personal UK Points must be purchased directly from FM World UK in February 2025.
- Business Partners who joined FM World UK on or before 30 November 2024 are eligible to participate.
- Additional business numbers CANNOT participate in the programme.
- Numbers acquired based on the Marketing Plan or Distribution Agreement, as well as numbers under management, CAN participate in the programme.
- The reward (double commission) will be paid in April 2025, provided all programme conditions are met.
- Participation in the “Déjà Vu – Magnolia Edition” programme does not exclude Business Partners from participating in other FM World UK incentive programs.
